### Physiotherapy Education:

The Estonian association does not have an education department. There is 2 physiotherapy school in the country graduating 15+5 students per year. Studies take 3+2 years (1 year correspond to 40 credit hours) resulting in 160 credit hours and lead to an academic degree/diploma. ### **Status of profession:**

**Professional Title/ Qualification:** Füsioterapeut The title and the professional activity is not protected by the state. There are no rules of professional conduct or regulations on the physiotherapy profession determined, and no registration or licence to practice is required. However, Estonia has established a code of ethics for physiotherapists. The national authority responsible for the physiotherapy profession in Estonia is the Ministry of Social Affairs. There are sufficient employment opportunities for physiotherapists in the country.

### **Practice of physiotherapy:**

The physiotherapy services in Estonia are not determined by the profession. The physiotherapist is not allowed to determine the clinical intervention of physiotherapy him/herself. Estonia offers mainly public physiotherapy services. The insurance cover for physiotherapy is paid through the national health care system as well as privately the patient.

### **Twinning:**

The Estonia Association has established a twinning program with Finland. No governmental or EU funding.
